GUIDELINES FOR CARRYING OUT BIOGRAPHIES

Dear Authors,

To facilitate the development of the Biographies book, proposed by UNIRIO, we are

developing these guidelines that can assist each of the authors.

1) Initially, I suggest that an informal consultation be made if the professional is willing to collaborate in the

structuring your biography;

2) After acceptance, we request that a time be scheduled for the collection of information prior to

interview, which contemplates the scope of the BASIC SCRIPT FOR WRITING AND

ORGANIZATION OF THE AXIS OF BIOGRAPHY, with the following elements:

- Text structure - Maximum of 5 pages with references in ABNT; Times New Roman font;

size 12; line spacing 1.5; margins of 2 cm. Do not add footnotes;

- A maximum of 3 authors per biography with their respective credentials, email and telephone number;

- Image of the biographer, preferably public or that is authorized in writing;
- Full name and, Name known;
- Parent's name;
- Date of birth and death, if applicable;
- Formation of the biographer and the institution of origin;
- Positions / functions exercised in the institutions;
- Most important achievements accomplished;
- Context, general or specific, of the circumstances; and
- References.

3) To assist in the development, the coordinators of the Work provide us with an example

published by VERBETE, in the personality of Alfredo Pinto Vieira de Melo, authored by

Alexandre Magalhães de Mattos.

4) We clarify that we can have as sources information in the professional's Lattes Curriculum, in the
